CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

OreCorp Limited (the **Company**) advises that on 9 September 2021 a total of 2,000,000 fully paid ordinary shares in the Company (the **Shares**) were issued pursuant to the Company's existing capacity under ASX Listing Rule 7.1 in connection with the acquisition of an interest in an exploration tenement located in Western Australia (refer ASX Release dated 8 September 2021 "Appendix 3B – Proposed Issue of Securities").
