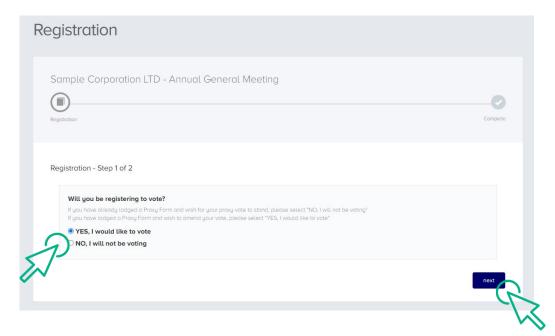

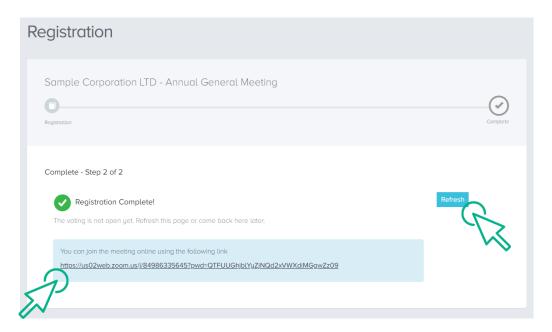


REGISTRATION
