# GRANT OF PROSPECTING LICENCES AND TRANSFER OF ENVIRONMENTAL CERTIFICATE, NYANZAGA GOLD PROJECT, TANZANIA




Figure 1: Nyanzaga Project Licences, Tanzania

OreCorp Limited (**OreCorp** or the **Company**) is pleased to announce the recent grant of two Prospecting Licences (**PL's**) contiguous with the Special Mining Licence (**SML**) at the Nyanzaga Gold Project (**Nyanzaga**) in Tanzania (*Figure 1*). The two licences secure the ground immediately around the SML, PL 11873/2022 to the northeast and PL 11874/2022 to the west and south of the SML. The applications were lodged shortly after the SML was granted and both licences were granted for an initial period of four years to Sotta Mining Corporation Limited (**Sotta**), the joint venture company in which OreCorp's subsidiary, Nyanzaga Mining Company Limited (**NMCL**) holds an 84% interest and the Government of Tanzania holds a 16% free carried interest.

The Company sees this as another positive step for the Tanzanian minerals industry and believes it demonstrates the commitment of the Mining Commission under the new regime of Her Excellency Samia Suluhu Hassan, the President of the United Republic of Tanzania, to progress the industry.
