CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

OreCorp Limited (the **Company**) advises that today a total of 1,200,000 fully paid ordinary shares in the Company (the **Shares**) were issued pursuant to the Company's existing capacity under ASX Listing Rule 7.1 in final settlement of the acquisition of the Company's 80% interest in the Hobbes Prospect E31/1117 located in the Eastern Goldfields of Western Australia (refer ASX Releases dated 18 February 2022 "Acquisition of remaining interest in Ringlock Dam Licence and settlement of Hobbes consideration" and "Appendix 3B – Proposed Issue of Securities").
